NO DEPOSITS OR CAMP FEES ARE REFUNDABLE AFTER AUGUST 1ST WITHOUT WRITTEN MEDICAL REASON. NO DISCOUNTS FOR LATE ARRIVALS OR EARLY DEPARTURES.
